**SCOPE**

1. This HUMINT directive gives formal direction to COMBRITFOR for [REDACTED], HUMINT operations (less SF) in support of UK Forces deployed on OP TELIC. This directive is for planning purposes only. It draws authority from Reference A and should be read in conjunction with Reference B - F.

**AIM**

2. The aim of this directive to define the concept of operations and command and control arrangements for HUMINT operations (less SF) supporting OP TELIC.

**MISSION**

3. The FHT and JFITs assigned to [REDACTED] are to undertake HUMINT operations, as directed, in order to assist in COMBRITFOR's PIRs.

**EXECUTION – CONCEPT OF OPERATIONS**

4. The assigned HUMINT units are to support COMBRITFOR by collecting HUMINT and will undertake the following tasks:

- a. [REDACTED]
- b. Military Liaison.
- c. De-briefing.

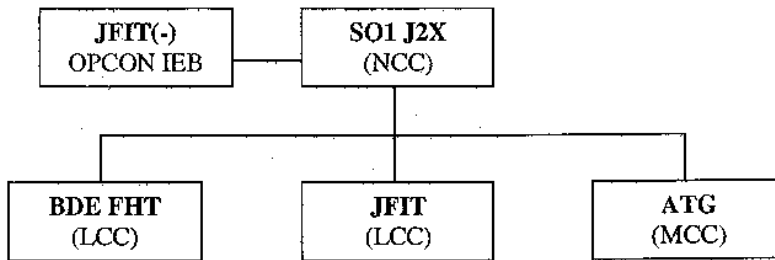

**CO-ORDINATING INSTRUCTIONS**

5. Composition. The [REDACTED] HUMINT effort is structured as follows:



A comprehensive ORBAT is contained at Annex A.

6. The responsibilities of SO1 J2X NCC are detailed at Reference A. Additional responsibilities include:

- a. Ensure that all Cat A PW or High Value Targets are reported to PHJQ J2X and PJHQ LEGAD. Para 68B(1) of OP TELIC ROE refers.

7. Legal Advice. HUMINT operations are subject to specific legal advice. The NCC LEGAD will be indoctrinated to HUMINT operations and provide appropriate advice. Any conflict between operational requirements and legal advice is to be highlighted to PJHQ J2X. The following Acts and Conventions are to be adhered to:

- a. [REDACTED] All HUMINT operations are to be run in line with Reference E. SO1 J2X is the appropriate authority; all completed [REDACTED] paperwork must be submitted to PJHQ J2X.
- b. The Geneva Convention. Interrogation, de-briefing and PH&TQ operations are to be conducted in line with the Geneva Convention. Further guidance on the Handling of POWs and detainees can be found at Annex B. SO1

J2X is to ensure that the NCC LEGAD approves methods and approaches for interrogation and de-briefing operations.

SERVICE SUPPORT

8. Interpreters. HUMINT units will have integral military linguists, however, there may be a requirement to utilise local or capitulated personnel to assist in language support. SO1 J2X is to authorise any HUMINT operation using local speakers ensuring risks to OPSEC is minimised.

9. ROE. The ROE are commensurate with that of the operation.
