1. SITUATION.

a. En Forces. Tgt is B11 from Op TAY, to be known as B1 for this Op his house A1 and place of work (MAW Bldg) A2. B1 is Iranian Int Agent, but also a cleric, there is a potential for a PO Situ. A1 lives with two other men UKMs, two women and at least two children, resistance is not expected at A1. A2 is a large bldg which has at least a 6 man armed Gd, incl a roof top sentry post, resistance is unlikely, but possible.

b. Friendly Forces.

(1) Bde Intent: Comd's intent is to conduct thorough searches of A1 and A2, in order to gain intelligence and evidence of B1 possible link to the deaths of the RMP on 23 Aug 03. If evidence is gained B1 is to be interned, if not B1 is to be released ASAP, to prevent a PO situ.

(2) Bde Assets. Coys to bid to OpsWO for AES Dogs as req'd. Ops Offr to book RESA & REST to Sp CORUNNA, incl Coy O Gp. Escort of RE assets fm RVs is a Coy responsibility, OpsWO to Co-ord. Ops Offr to book Avn topcover for Op, Aerial LO will be OC SOMME. BGIRO is to request a TQ fm Bde - Suggest Maj Radbourne.

(3) OP Pty. ANZIO already has an OP at Czech Mil Hosp and will continue surv on A1, Op will not be triggered if unless B1 can be kept in custody throughout searches.

2. MISSION. No change.

3. EXECUTION BMI Downgrade - RESTRICTED

a. Concept of Ops.

(1) Intent. My intent is to disrupt possible terrorist activity being orchestrated by B1 from the MAW bldg. This will be a BG temporary lift Op in order to complete searches for evidence with a view to internment as required for B1 and possibly others. Speed is essential in order to prevent an unnecessary PO Situ developing.

(2) SOM. The ANZIO OP, will confirm the presence of B1 in A1, triggering a synchronised Lift and Search Op. ANZIO will soft knock A1 and arrest B1 and other males. Arrestees must be removed to BG MAIN HQ Loc ASAP, whilst searches are ongoing. Simultaneously CORUNNA will secure, by soft knock unless contacted, the MAW Bldg A2 Gd QU 681829. Once secure A1 & A2 are secure they are to be thoroughly, but expeditiously searched. Evidence is to be removed to 1 QLR BG MAIN HQ as it is retrieved to allow analysis with a view to Tactical Questioning. BURMA are to BPT to deploy to contain a PO situ if it develops, triggered by Aerial Surv, PO situ is likely to whipped up by Religious Gps due to B1 being a cleric. Cordons are to collapse under OsC as soon as searches are complete. If evidence allows prisoners are then to be TQ with a view to internment, otherwise they are to be released. Prisoner handling and evidence examination is to be conducted by the IO, BGIRO assisted by TQ fm 19 MB TCC if avail and Provo Sgt. Prisoners are not to be conditioned unless TQ is authorised on the basis of substantial evidence found during searches. Guarding of Pris and possible subsequent transfer to the TIF will be an ANZIO responsibility.

(3) ME. Prevention of an unnecessary PO Situ. (PO Situ is deemed as unnecessary if evidence leading to internment is not found)
