### Inquiry Chairman issues rulings

The Chairman of the Baha Mousa Inquiry, the Rt Hon Sir William Gage, has today published his rulings following the first Directions Hearing on 3 December 2008.

The rulings relate to applications made to the Chairman which sought:

- (i) an extension of the undertaking already given by the Attorney General to provide further protection to a witness against self-incrimination;
- (ii) undertakings to be given by the Director of Public Prosecutions replicating those given by the Attorney General;
- (iii) undertakings to be given by the Permanent Under-Secretary at the Ministry of Defence and by the Chiefs of Staff of the armed forces not to use evidence given by a witness to the Inquiry in disciplinary proceedings;
- (iv) undertakings providing protection in respect of possible proceedings in foreign courts.

The rulings and undertakings relate to the status of evidence and information provided to the Inquiry; they do not provide any form of immunity against prosecution.

The Chairman has indicated that a second Directions Hearing will be held on Monday 19 January 2009, continuing on Tuesday 20 January if necessary.

Court Reporting Rules: Sir William Gage highlighted at the Preliminary Hearing that at the Court Martial of seven servicemen arising out of these events, the presiding Judge Advocate made an order, which remains in force, requiring the media not to publish certain features and information relating to those defendants.
